



Uniform Order & Charges from APRIL 2025

Three- and four-year-old children are eligible for Universal Government Funding for up to 15 hours per week for 38 weeks each year which can be shared between two providers of nursery education. Subject to meeting criteria, working families may be eligible for an Extended 15 hours Government Funding which can be applied for at www.childcarechoices.gov.uk.

If your household income is less than £16,190, some children may be entitled to 2-year-old targeted funding for up to 15 hours per week which can be applied for at www.bracknell-forest.gov.uk. Subject to meeting criteria, working families of 2-year-old children will be entitled to 30 hours Government Funding which can be applied for at www.childcarechoices.gov.uk.

UNIVERSAL EARLY EDUCATION IS FUNDED BY THE GOVERNMENT when a child reaches the age of three –
 between 1st January and 31st March - FUNDED from the following Summer Term
 between 1st April and 31st August - FUNDED from the following Autumn Term
 between 1st September and 31st December - FUNDED from the following Spring Term

Fees for unfunded children or hours in excess of those funded: £8.75 per hour

Registration Fee for fee paying hours (Non-refundable) for a place on the waiting list of nursery: £35.00 per child

Six weeks notice is required before the removal of a child or six weeks fees will be payable in lieu of notice.
 Fees are payable termly in advance, by the end of the first week of attendance in any one term.
 Late payment of term fees may incur a handling charge of £2.50 per day.

A VOLUNTARY consumables/enhancements charge of £1.50 per morning session and £1.50 per afternoon session is appreciated for all government funded children with the exception of children in receipt of targeted funding or Early Years Pupil Premium.

Parents/carers wishing to opt out of this charge can do so and will be required to provide a snack for their child each session, in addition you will be provided with a list of consumables which you will need to provide for your child each term, to be provided on/before the first day of term.

Additional ad hoc nursery sessions booked will incur an additional administration charge of £0.75 per hour.
